PRESIDENT'S STATEMENT

Background

Wildlife At Risk ("WAR") is dedicated to protecting the biodiversity of Vietnam by combating the illegal wildlife trade, raising environmental awareness and promoting the conservation of endangered species and their habitats.

WAR is a non-profit organization, registered in Delaware on 5th October 2003. It is based in Ho Chi Minh City ("HCMC") and active throughout the southern provinces of Vietnam.

Vietnam's wildlife faces a desperate fight for survival in the 21st century. Without urgent intervention, many of the country's endangered species will soon be wiped out. They are being driven to extinction by habitat loss, hunting, pollution and, above all, the flourishing illegal wildlife trade. WAR aims to reduce the pressure on Vietnam's threatened biodiversity by helping to build local capacity to implement legislation, raise environmental awareness and develop alternatives to the unsustainable exploitation of natural resources.

Responding to specific priorities identified by local government, and working with appropriate specialists and project partners, WAR focuses on three interlocking themes:

- Enforcement Action to reduce the exploitation of endangered species and to support the confiscation, rehabilitation and possible release of illegal traded wildlife;
- Raising awareness Influencing behaviour, changing attitudes to wildlife and promoting sustainable use of natural resources; and
- Protection in the wild In site conservation to safeguard specific endangered species and their habitats.

WILDLIFE AT RISK - ANNUAL REVIEW 2014 - 2015

Overview

The main focusing of Wildlife At Risk from this year is Biodiversity conservation and Raising public awareness on conservation. WAR has reached several successes on wildlife conservation over the past 12 months from July 2014 to June 2015. Twenty (20) endangered wildlife born at our rescue centres and most had been released to the wild. Beside this direct contribute to protection wildlife and conservation biodiversity, WAR has continued focus on public awareness on conservation. Messages on biodiversity conservation are regularly transferred to communities through public events such as wildlife photos exhibitions or programs with students and release news of biodiversity findings on WAR website and to local public media. WAR still keeps its position as one of the most experienced NGOs in the field of wildlife rescue in Vietnam. Due to WAR's experience there is a great demand from local partners for assistance with their wildlife rescue activities and staff training. Through the regular release of wildlife it is possible that the biodiversity and species population can be both protected and conserved.

WAR has continued to follow up its previous ground work in the area with several public awareness projects to educate young people and raise awareness of local communities.

The following figures reflect the impact of WAR's activities on natural conservation in Vietnam and also the challenges faced by the organisation during the period July 2014 to June 2015:

- Approximately 1,600 heads of 50 types of wildlife have been transferred to the Wildlife Rescue Station ("WRS") at Cu Chi Wildlife Rescue Station ("CCWRS") and Hon Me Wildlife Rescue Station ("HMWRS") in Kien Giang province. 93% of the wildlife had been released after a period of rehabilitation. The figure has a slightly increase compare to the previous 12 months. WAR is still facing challenges of rescue wildlife.
- Approximately 1,500 heads of fresh water fish have been released back into the Saigon River and her tributaries. This activity still received interests from young students and illustrates the positive action of conservation by the students. The captive breeding programme for conservation will enhance conserve the biodiversity of Vietnam.
- Within the last 12 months, wildlife breeding successfully at WAR rescue centre include: small-clawed otter, leopard cat, Black bear, yellow-cheeked gibbon, pangolin, elongated tortoise, yellow head temple turtle. Several offspring of the wildlife are released back to the wild in appropriate habitat. The others are considering and finding suitable habitat and/or facility to release/transfer. Activity of captive breeding for conservation at WAR facility is direct contribution to conservation and biodiversity.

• A model of ex-situ conservation of gecko are experimental one at our wildlife rescue center to ensure a resources for any lost of species in future due to development activities. Initial positive signal is an optimistic promise to our efforts. The model to be kept and run in the next 12 months for further information.

WAR is now calling for support and co-operation from various communities:

- This year, more than 40 students from Ho Chi Minh city, Hanoi and other provinces visited Hon Me Wildlife Rescue Station to help maintain the wildlife rescue facilities by planting more than 100 fruit trees and vegetable.
- Approximately 1,700 visitors and students visited CCWRS.
- 14,000 students from 12 secondary schools in HCMC have benefited from participation in our SOS exhibition tent project where wildlife education is the central topic.
- 4 trips for biodiversity surveys have been conducted at Bi Doup National park of Lam Dong province and Hon Khoai island of Ca Mau province. WAR has cooperated with young Vietnamese scientists of The Institute of Ecology and Biological Resources to implement the surveys. The aim of these surveys is to contribute to species distribution by releasing wildlife from the rescue centres. It also helps to enhance knowledge and information on biodiversity for wildlife education and by raising public awareness of the surveyed areas and in Vietnam in general. A remarkable point of the biodiversity survey in this year is an action of amending on breeding facilities at the WRS to be more close to natural system.

The overall budget for 2014 – 2015 is approximately USD592,456 of which USD341,036 has been spent on WAR's enforcement missions across wildlife rescue stations at CCWRS and HMWRS. USD121,361 has been used on public awareness projects and nearly USD74,690 has been used for biodiversity surveys and captive conservation, highlighting our commitment to Vietnam's wildlife and their habitats. The remaining budget was spent on administration. Again, the budget was increased this year which meant we were able to save more wildlife and protect more biodiversity through by all means. The increased budget has also helped WAR develop in scope and scale over the last 12 months.

The new registration of WAR to work in Vietnam for the next 5 years had been granted (2015-2020). This will support to our efforts to implement long term plan to conserve biodiversity of Vietnam. WAR continues to build on its positive working relationship with the Forestry Protection Department ("FPD") in Ho Chi Minh City, Kien Giang and throughout Vietnam, as well as with the city/province Union of Friendship Organisation. In addition, WAR received support from international experts, volunteers for biological surveys on the subject of conservation and biodiversity protection highlighting WAR's commitment towards Vietnam's unique biodiversity.

Enforcement

A reality of more wildlife transferred to WAR's WRS reflects actions of authorised agencies on illegal wildlife trade. In order to meet the demands of support and learn from the agencies, WAR' WRS also have to extend facilities of rescue and resources for rescue. The resources are not only the physical one to display for learning but also the expertise on biodiversity and conservation wildlife.

The rescue centres have achieved several important milestones in the last 12 months: firstly, the HMWRS has developed a trial model of ex-situ conservation for gecko. Once it is success, the model will be a standard to care different type of endangered gecko/lizard. The facility also demonstrate a differences between an enclosure of wildlife farm and a facility conservation wildlife. As usual, annual fruit trees to support wildlife' daily food was planted in the beginning of rainy season. Water tanks, solar system are maintained and installed more to ensure an environmental friendly rescue station, which use mostly the recycle resources. Over the last 12 months, HMWRS had received over 20 wildlife of different species and most are released back to nature, mainly in the Mekong delta.

The CCWRS is still WAR's most busy rescue centre. 1,500 heads of different wildlife have been transferred to this centre in period 2014 – 2015. Overtime work is still called to animal keepers to save and rescue wildlife. Thanks to the working spirits of WRS' staff and this is an invaluable thing of WAR which is formed in the last 11 years. The new 8m2 surgery room has recently been equipped with veterinary equipment/ tools for operation large mammal. WAR is calling more support for medicine and tools for the room. WAR Vet activities at the CCWRS are being developed, step by step, in a professional and systematic manner. We are confident in saying that the CCWRS is proving very useful for local agencies in enforcing the fight against illegal wildlife trade and to provide any information when requested by the authorities.

During the past year 2014 – 2015, WAR welcomed more than 30 international volunteers, from different countries, to provide help for WAR staff and wildlife at CCRWS. WAR would like to thank all the volunteers for their positive contribution towards saving Vietnam's endangered species at CCWRS and their ongoing friendship.

Raising Awareness

The SOS Exhibition project has continued to run with interest from the Department of Training and Education of Ho Chi Minh City. The program has benefited more than 40,000 students who have had the chance to learn and explore conservation activities in the year 2014 – 2015. WAR continues its commitment to the long-term strategy of developing activities and presentations to attract students and public for wildlife protection and ultimately save Vietnam's biodiversity and its beauty forever.

A total of 40 students from Ho Chi Minh city and Hanoi and two other provinces have been awarded a trip to one of WAR's wildlife rescue stations to work directly with animals and to have the chance to learn and practice wildlife survey activities. The remarkable of the program in this year has opened broadly at national wide to involve students from different local.

At CCWRS, the 1st floor of the education centre had been opened for visitors, after nearly a year of construction and decoration. Still a lot of work and things need to be done for the education centre. WAR hope the centre will transfer more information to visitors and students on biodiversity and conservation wildlife.

Success in both number of visitors and activities last year meant that WAR decided to keep developing these initiatives and as such tours for children and students to visit CCWRS and HMWRS, where they could observe non-releasable wildlife in semi-natural environments, continues. Students are also able to participate in releasing native fresh-water fish species into the Saigon River which WAR has bred at its head office.

Protection in the Wild

In this year, WAR' captive breeding activities is not only work on the fresh water fish, but also success on small mammal e.g. leopard cat, otter and one of the big carnivore is the black bear. The breeding activity is the very first step to formulize a long term program of captive breeding for conservation. The further action will be discussed with WAR' partner and experts within WAR capacity and resources. A total of 1,600 fresh water fish of Beta species and several native ones have been released to the river during the last 12 months (July 2014 to June 2015). WAR's fresh water fish facilities allow people to visit and also get work experience. Our overall objective on conservation and captive breeding for conservation is to increase number of species those over exploited to ensure the genes diversity within a species population. WAR, with its limited human resources, will implement programs that focus on some selected species which are:

- 1) Suitable to the environment in Southern Vietnam;
- 2) Could be used in a combination of wildlife education on release activities.

WAR will keep expanding its capacity for captive breeding for conservation of other species such as: fresh water turtle, gecko, leopard cat, otter and pangolin. Over a period of ten years working in wildlife rescue and release, WAR start to release our practical observation with a number of wildlife on rescuing and breeding endangered wildlife. The reports are expected to assits managers and other interested person have more information.

Annual biodiversity surveys, in co-operation with experienced experts who volunteer to work for WAR, are still being implemented. As usual results of all surveys are released to the public and are also available on WAR's website. Information of new distribution species in Vietnam and checklist of the survey are regularly released and updated on WAR website.

Expanding our ambitious of protection endangered species which are threatened and only found so far in Vietnam, WAR in cooperation with a local research institute on wildlife and ecology start to conduct a trial model of ex-situ conservation at one of our wildlife rescue centre. Initial success so far is an encourage to WAR and WAR staff on the efforts to save and protect more species. This action meets our objective on conservation biodiversity.

Human Resources

Though, there is a change of staff over the last 12 months, the total number of WAR staff is stable. A total of 28 national staff and one British expatriate, are committed to work with WAR to save Vietnam's wildlife. Experienced volunteers have made a significant contribution towards WAR's work, particularly at the CCWRS and in field of biodiversity surveys. This is helping to enforce and further WAR's efforts and reputation both nationally and internationally.

Along with WAR's development, many caring individuals, companies and organisations have contributed towards WAR's mission on saving Vietnam's endangered species and have joined WAR to save Vietnam's natural heritage and resources for future generations.

1 Summary of significant accounting policies

The following significant accounting policies have been adopted by Wildlife At Risk in the preparation of this statement.

(a) Basis of preparation

The statement of receipts and payments, expressed in United States Dollars ("USD"), has been prepared in accordance with the cash receipts and disbursements basis. This is a basis of accounting that is designed to meet the requirements of Wildlife at Risk; it is not designed to produce a statement of receipts and payments that is compatible with International Financial Reporting Standards. On this basis, income is recognised when received rather than when earned; advances to project staff are recorded as expenditure when the advances are liquidated; other expenditure is recognised when paid rather than when incurred.

(b) Foreign currency transactions

Transactions in currencies other than USD during the year have been translated into USD at the rates approximating those ruling at the transaction dates.

(c) Non-expendable equipment

The cost of non-expendable equipment is charged to expenditure upon acquisition.
